REPORT OF THE MANAGER TO THE UNITHOLDERS

DA CHENG CHINA BALANCED FUND (A SUB-FUND OF DCI INVESTMENT TRUST)

Fund Performance

Da Cheng China Balanced Fund (the "Sub-Fund") seeks to provide long-term growth of capital and income. As of 30 June 2018, the Net Asset Value ("NAV") per unit of the RMB Class A was RMB 13.33, the NAV per unit of the USD Class A was USD 12.11, and the NAV per unit of the HKD Class A was HKD 12.25, aggregating a total asset size of approximately RMB 2,917,996,612.

Market Overview

A-shares sank most in June in almost 30 months with CSI300, Small-and-Mid Enterprise Index and Chi-Next sliding over 7%, under both external shocks and domestic pressure. The external environment continued to deteriorate. First, the trade spat between China and the US escalated, resulting in both sides' decision to raise tariffs on each other. Second, the US dollar strengthened, sending the exchange rate of RMB against the US dollar to 6.61, and spurring pessimistic expectations about RMB assets. EPFR data showed that funds began to flow out of China.

The expectation towards domestic economy and policies turned to be pessimistic. On the one hand, the deleverage campaign exceeding anticipation, the drastic drop of social financing in May, the surging number of credit defaults, and the forced sales from stock pledges all weighed on the market risk appetite; on the other hand, the outlook of CDR became uncertain and concerns arose on the liquidity dry-up effect of "unicorns". As for sector wise, all industry gauges dropped throughout the month, while F&B, home appliances, and leisure services were relatively defensive.

Heading to the second half of the year, the marginal changes in domestic policies could be an important factor affecting the market. We expect that the probability of further fine-tuning of domestic macroeconomic policies will increase under the background of intensified external shocks, aiming to balance "expansion of domestic demand" and "de-leverage campaign". The monetary policy is expected to be neutral and loose, and the general fiscal spending will be more aggressive, promoting social financing and infrastructure investment growth to stabilize and avoid rapid economic stagnation.

Considering that the fine-tuning of domestic policies will boost the stock market sentiment and that the improving liquidity will benefit bonds, our asset allocation strategy is more optimistic than in the second quarter, suggesting a balanced allocation of stocks and bonds. In terms of stock selection, we will focus on "domestic demand stocks": 1) bellwethers in upgrading consumption that are reasonably undervalued in comparison with global peers, such as medicine, tourism, food and beverages; 2) cyclical stocks that will benefit from excellent mid-year report and eased credit policy, such as steel and building materials; 3) growth stocks that are oversold in dips, such as military and computing.
