REPORT OF THE MANAGER TO THE UNITHOLDERS

DA CHENG CHINA BALANCED FUND (A SUB-FUND OF DCI INVESTMENT TRUST)

Fund Performance

Da Cheng China Balanced Fund (the “Sub-Fund”) seeks to provide long-term growth of capital and income. As of 30 June 2019, the Net Asset Value (“NAV”) per unit of the RMB Class A was RMB 13.85, the NAV per unit of the USD Class A was USD 12.10, and the NAV per unit of the HKD Class A was HKD 12.18, aggregating a total asset size of approximately RMB 2,262,360,323.

Market Overview

During the first half year, A-share equity market got lifted first and saw correction afterwards, amid which Shanghai Composite Index has been rising for 19.4%. Sector wise, all major sectors advanced, with Food & Beverage, non-bank financials and agriculture recording the most gains. The sectors including Construction & Engineering and Steel were flat.

Global risky assets put on the “risk-on” sentiment in the first quarter of 2019, among which A-share outperformed globally, while the change of interest rate and risk sentiment played critical roles: 1) Major global central banks switched to a more dovish tone; social financing rose sharply in China, and easing liquidity led to rapid expansion in valuation; 2) Trade wars took a truce, Tech Board also accelerated and more counter-cyclical measures announced from policy makers, risk appetites in the A-share market rose sharply.

However, the market started to fluctuate in the second quarter. Due to PBoC’s reiteration of “controlling overall money supply” in April, escalation of trade tensions in early May, as well as weakening signs shown from domestic macroeconomic data and the takeover of Baoshang Bank and its credit risk, A-share slumped from April’s high and major indexes waved within a small range.

Outlook

As for the market outlook in the next half year, we are not pessimistic, since part of pressure on the A-share market has been alleviated:

Firstly, PBoC has been injecting liquidity into the market since June, so that the liquidity situation has been marginally improved; US Fed may also start the cycle of interest rates cut, paving ways for more easing policies in the second half of the year.

Secondly, agreement has been reached by US and China during G20 Trump and Xi’s meeting in the late of June. Both sides agreed to halt tariff lifting. Meanwhile, overseas fluctuations and RMB depreciation risks deceased, leading to less pressure of foreign capital outflow.

Moreover, economy and corporate earnings may stabilize in the second half of the year, with A-share is likely to embrace structural opportunities. Under the assumption that there are no additional tariffs in the next half year, the profitability of non-financial companies in A-share may be bottom out in or ahead of Q3; the overall earnings growth is estimated to be around 6.2%. In sector allocation, China’s advantaged enterprises and consumption discretionary are worth investing.
